Course Description

This course is on the themes and debates in the history of the modern Middle East. The course will examine selected aspects of politics and society in the Middle East and will cover the period from the late Ottoman rule up until recent times. It will explore a number of theoretical and methodological questions related to the study of the region. The extent of the course is not limited to high politics, but it aims to present a bottom-up approach to the histories of colonialism, state-making, nationalism, decolonization and state-society relations in the post-colonial period.

Requirements

- Active participation in classroom discussions. (20 %).
- Three position papers, 3-5 pages in length and one presentation (40 %).
- One term paper, 10 pages in length (due at the end of the semester) (40 %).
