ATA 686: Work and Workers in Comparative Historical Perspective

This course deals with the history and theory of labor process and labor movement in capitalist societies. Main areas explored include the historical changes in the structure of employment and patterns of work, meaning and composition of work, and the challenges workers and labor organizations currently face in different societies. The discussion of the readings on these issues will be complemented with four films directly relevant for the subject matter of the course.

Course evaluation will be based a) on a paper presenting an overview of the world of labor in contemporary Turkey and discussing issues such as unemployment and insecurity of employment, informal labor, gender and work, immigrant labor based on data from national and international sources (i.e. OECD and ILO), policy documents and secondary sources (see the readings for week 9), and b) a paper discussing the four films by situating them in the context of the course readings and class discussions. The first paper will be handed in the last week of the classes and the second one week later.

Contribution to class discussions around the required readings and following the films is also important.
